
I. ELIGIBILITY

To be eligible to receive this scholarship, applicants must meet the following minimum requirements based on their classification:

- A. Four Year Institutions: (1 per year)
 - 1. Must have a major in real estate or finance with a degree plan on file with the college
 - 2. Must have completed a basic principals course in real estate and one other real estate course
 - 3. Accumulative overall GPA in real estate courses of 3.0 or above
- B. Community Colleges: (2 per year)
 - 1. Must have a major in real estate (degree plan should be on file with the college)
 - 2. Must have completed at least 12 credit hours
 - 3. Have a minimum 3.0 accumulative GPA in core real estate courses
- C. Proprietary Schools: (2 per year)
 - 1. Must have completed six hours of required core courses
 - 2. Exhibited exceptional ability in test scores
 - 3. Must have been recommended for this scholarship by at least three faculty members of the proprietary school
- II. TIMING OF COURSE APPLICATIONS. All requirements must have been met within the last two years.
- III. THE SCHOLARSHIP APPLICATION COMMITTEE. The Committee will consist of three members of the Texas Real Estate Teachers Association.
- IV. Texas Real Estate Teachers Association will deposit \$50,000 as an endowed fund and give no more than five \$1,000.00 scholarships per year.
- V. All applications should be made to president@treta.org by January 1st of each year.
